"APPLICANTS GENERALLY INELIGIBLE: Farmers/Ranchers/Aquaculturists:

- 1. Under § 7(b) of the Small Business Act, SBA may <u>not</u> provide disaster loans to agricultural enterprises. A business may be primarily an agricultural enterprise but also have a non-agricultural, separable component. The non-agricultural venture may be eligible for a business physical disaster loan regardless of the "primary" activity of the overall business structure or affiliated group. To be eligible, the non-agricultural venture must be a separable operation and not just part of the agricultural enterprise, with separable and distinguishable income, operations, expenses, assets, etc.
- 2. Section 18(b) of the Small Business Act defines agricultural enterprise as those businesses engaged in the production of food and fiber, ranching, and raising of livestock, aquaculture (see exception in subparagraph 3 below), and all other similar farming and agriculture related industries. This definition is not limited to products for human consumption. Most agricultural enterprises fall into Industry Sector 11 of the North American Industry Classification System (NAICS)."
