AN IMPORT PERMIT IS PRESENTED.

FRUIT - (not Plants or Seed)

All containers **MUST** be shipped under either packing house or shipping line seals. The ocean freight container numbers and the corresponding seal numbers **MUST** be listed on the phyto under the “Distinguishing Marks” section.

Please inform shippers that the container numbers and the corresponding seal numbers must appear on the shipping documents, including the Inward Cargo Manifest and Bill of Lading. All unused space on the Phyto must be lined out.

Must be free from soil.
